added phonetic spelling. Just make a note of that on your  
paper, and I'll excuse it.

Take BOX mugshots of Thomas and

Pringle

Notice I chose a BOX shot of  
Chip, so I also needed to take a  
box graphic (mugshots).

Two men are in custody after they led  
police in a chase through Tazewell  
County Monday.

Take VO [wide shot of Beck Oil  
building]

Locator - CG#: \$\$\$\$

Pekin

Monday

(Take at:0:00)

Locator tag with place and time.  
(Don't worry about "take at" time.)

Police say it started with an armed  
robbery around six p.m. at Beck Oil in  
Pekin (PEE-KIN)...

Continue VO [wide shot of Beck Oil  
interior with police tape]

These shot descriptions go in  
"Video ID" when you add a new VO.

...where Joshua Thomas (TOM-US),  
held a clerk at knife-point...

Continue VO [wide black and white shot  
from security camera feed of Thomas  
robbing clerk]

Notice how often I change shots.

...then ran off with cigarettes and  
money.

Continue VO [wide black and white shot  
from security camera feed of building  
exterior as Thomas flees to van]

Police say waiting for him in a van  
was Brian Pringle (PRING-GULL).

Continue VO [medium close shot of  
"Speed Limit 25" sign, with long, dark  
road in background]

At speeds between thirty and seventy  
miles per hour, the men led officers  
through Pekin (PEE-KIN), South  
Pekin (PEE-KIN), Tazewell County,  
and Morton.

Continue VO [wide shot of police car]

with flashing lights on the side of the road]

They were finally stopped by a deputy who used a car maneuver (MUH-NEW-VER).

Continue VO [medium shot of Officer Bitner demonstrating tazer operation]

One suspect had to be tazed, twice.

Take SOT Runs.. 0:05 ..on the road" [close-up of Officer Bitner]

"We're very cautious at excessive speeds, and lucky no one else was on the road."

Take VO [medium wide shot of Pekin Police Department lobby, where officers escort Thomas and Pringle into jail cells]

After all this VO, here's my SOT, which can be as short or long as you want it. Type the entire soundbite, the outcue, and time it. Don't forget to describe the shot and add a name tag (name and role). Again, "take at" time is not important.

Back to more VO.

Police say Pringle (PRING-GULL) and Thomas (TOM-US) have extensive criminal histories.

Continue VO [medium close-up of Pringle and Thomas sitting down in jail cell]

Between the two, they're facing more than half a dozen charges...

Continue VO [close-up of Pringle, as the jail cell door is shut in the foreground (out of focus)]

...including armed robbery, aggravated fleeing and alluding, driving with a revoked license...

Continue VO [close-up of Thomas with bars in foreground]

...illegal transportation of alcohol and resisting arrest.

( Chip / 2shot )

And now, back to the anchor in the studio. The PDF is missing the last page, so you miss the last thing Chip says.
